### STUDENT'S RIGHT TO CANCEL

#### STUDENT'S RIGHT TO CANCEL AND REFUND INFORMATION

You may cancel your contract and obtain a refund of charges paid for school without any penalty or obligations before midnight on the seventh day after enrollment or after your first class session, whichever is later, by hand delivering or mailing a completed Notice of Cancellation form to the address shown on the front of this Agreement. You have the right to withdraw from a program of instruction at any time.
